In response to our advertisement dated: / /20 you had applied for the post of Lecturer and you were interviewed for the above post by the Selection Committee appointed by the Maharashtra University of Health Sciences, Nashik, I am pleased to inform you that the management as appointed you on the said post in Ashvin Rural Ayurved College, At. Manchi Hill, P.O: Ashvi Bk, Tal- Sangamner in the Scale of Rs. 8000/- with effect from joining date.

Your Appointment is Subject to the following terms and conditions.

1. The status, Code of Conduct, Ordinances and rules and Regulations laid down by the Maharashtra University of Health Sciences, Nashik and State Govt. will govern your Service from time to time.
2. (a) You are appointed in clear vacancy on full time/part time basis on probation for a period of -----year(S) from the date of joining.
(b) Your appointment is purely temporary for a period of -----
(c) Your appointment is on the leave vacancy for the period from Regular
(d) The post is reserved for S.C/S.T./N.T./O.B.C./VJNT Category since you belong to the said category, you are appointed on full time basis on probation for Two years from the date of joining.
(e) The post is Reserved for -----since you do not belong to the said category, you are appointed on time being on temporary basis against the reserved post for a period of year you shall not have any claim on the said post in the future.
(f) This is temporary vacancy caused by -----hence you are appointed full time on purely temporary basis for a period of -----
(g) Your appointment is on part time/Clock Hours basic only.
3. (i) You will be paid basic pay of Rs. 8000/- per month in the scale indicated above you will also be in titled to Durance Allowance, House Rent allowance at the rates of prescribed by the

- Sanstha/State Govt. from time to time. In case you are appointed for a period of more than one year you will earn annul increment.
- (ii) You shall be paid remuneration at the rate of Rs. -----per lecture/per hour.
4. You shall have to acquire the qualification Ph.D (M.Fil/Ph.D./M.D./M.S., M.D, M.S.C.) etc. as prescribed by the University/State Govt. or the Central Council Concerned written the stipulated period.
 5. Your Appointment is subject to the minimum no. Students and work load prescribed for the post.
 6. You shall submit the originals as well as certified true copies of relevant testimonials such as birth date Certificate change of name certificate (if any) etc. before joining the duties.
 7. In case you accept the appointment you shall have to execute deed of contract of service as prescribed in the Status at the time of joining the duties.
 8. You will be allowed to join the Duties on producing of
 - i) Two passport photographs
 - ii) Character Certificate from the previous employer (if any)
 9. You shall undergo Medical Examination by the approved Medical officer or by the Civil Surgeon at the place of your duty, with in three months from the date of joining duty. The appointment shall be provisional and condition, pending submission of medical certificate stating that you are free from any contagious disease and that you are physically fit for employment for on the staff of the college/institution.
 10. You are required to give the correct mailing address as soon as you join the duties and any change in the address earlier should be communicated to the principle. It will be presumed that any letter sent by registered post Acknowledgement Dues (RPAD) on the address given. Shall be deemed to have acknowledgement duty singed by you.
 11. You will not conduct or engage your self in private tuitions or caching classes.
 12. You will not engage yourself in any other job paid full, part time or otherwise during the continuance of your service without the permission of the competent authority/management.
 13. Your service are transferable to any other colleges/institutes run by the management.
 14. Your appointment may be terminated , at any time, by either side/party, by giving one months notice or one month pay in lien of notice period in case the period spent in service is more than six months.
 15. If you are found absent continuously for more than thirty days without permission your service will stand terminated automatically. If you are found guilty of violation of any terms and conditions maintained about you will be liable for disciplinary action and punishment decided by the management as provided for in the statues. During the period of service you shall not directly or indirectly do such things which are subversive to the interest of the society/University/Institutes/College/Students.
 16. You have to communicate your acceptance to the Management/College/Institution with in seven days from the date of receipt of this order of appointment, falling which your appointment is liable to be cancelled.
